We must provide ALL our own judges. This Judge Designation Form must be received by Roberta Hyland **NO LATER THAN MARCH 29, 2008**. JUDGING REQUIREMENTS:
 Student Congress = 1 Judge per Diocese
 Policy Debate = 1 and 1/2 Judges per Team
 Public Forum Debate = 1 Judge per Team
 Lincoln-Douglas Debate = 1 Judge per Debater
 Speech = 1 Judge per 2 Entries (a duo is one entry) or Fraction

Schools in the Arlington Diocese may combine with other schools in the Arlington Diocese to supply judges. Schools in the Washington Archdiocese may combine with other schools in the Washington Archdiocese. **Arlington schools may NOT combine with Washington schools to supply judges. Judge pools may NOT be combined between events (except within speech events); therefore, your judge commitments must be met separately if you have students competing in more than one event at the national tournament.**

We need to select from among the judges for both dioceses those we believe are the best qualified for elimination rounds. A student MUST have been out of high school 18 months to be eligible to judge elimination rounds. Please give all requested information for all judges. All eligible judges will have an elimination judging obligation. NCFL rules require judges to have experience judging the event assigned to them.

THE PENALTY FOR DROPPING A JUDGE WITHOUT A REPLACEMENT IS A FINE OF \$600. IN ADDITION, A JUDGE NAME CHANGE AFTER THE OFFICIAL REGISTRATION IS SENT IN WILL RESULT IN A FINE OF \$20.00.
