

**WASHINGTON-ARLINGTON CATHOLIC FORENSIC LEAGUE
MEMBERSHIP FORM**

All member schools must complete application for membership yearly.

Application consists of the following:

- 1) Completion of the WACFL Membership Form signed by the school principal or director of activities.
- 2) Completion of the attached National Catholic Forensic League (NCFL) School Data Card, signed by the school principal.
- 3) Payment of Dues: Make Checks payable to WACFL.
 - Either \$125.00 or \$225.00 (\$75 for new schools in the first membership year) to accompany application.
 - Electing the \$125.00, or new school \$75.00, option incurs a \$5.00 fee per entry at each event.
 - Electing the \$225.00 option incurs no additional fees at each event.
 - Under both options, there are modest fees at the Championship Tournaments in March and for tournaments with more than 4 events if designated.
 - Schools that are joining WACFL for the first time may choose to pay only \$75.00 accompanying this application. With this option, there will be a \$5.00 fee per entry at each event during the year.

IN ORDER FOR A STUDENT TO PARTICIPATE IN ANY WACFL EVENT ALL THREE APPLICATION REQUIREMENTS MUST BE MET. THERE ARE NO EXCEPTIONS MADE. The validation of any qualifications won at a tournament prior to completion of these requirements is contingent upon completion of these requirements.

SUBJECT: Invoice for 2016-2017 Membership Dues

DATE: 5 August 2017

1. The Washington Arlington Catholic Forensic League (WACFL) provides a forum for interscholastic debate and speech competitions among public and private schools in the Washington metropolitan area. Five tournaments are held in each of five events between October and February. At these tournaments, students qualify for the Metropolitan Championship Tournament in each event held in March.
2. Membership in the WACFL must be renewed each year. Membership procedures consist of completing the appropriate registration forms and paying the appropriate membership dues. Additional entry fees are required at the Metropolitan Championship Tournaments and for tournaments with more than 4 events if designated, regardless of the dues option selected. Following are the three dues structures for membership in the league.
 - (1) The most cost effective membership option is to pay \$225 by October. This allows unlimited entries at unlimited preliminary WACFL tournaments.
 - (2) Schools may pay \$125 in October. Using this option requires that a \$5.00 fee per student per entry be paid at every preliminary WACFL tournament throughout the year.
 - (3) Schools new to our league may pay \$75 in October. Using this one-time-only option also requires payment of a \$5.00 fee per student per entry at every preliminary WACFL tournament throughout the year.
3. Two membership data forms must accompany the payment of dues: the WACFL membership form, and the National Catholic Forensic League data card. Both forms must be signed by the principal of the school. In spite of duplicated information, both forms must be complete since the school data card is sent to the national committee.
4. Membership in the WACFL, as well as all student qualifications, is contingent upon the receipt of both forms and dues.
